Open Studio Tour Participation Agreement 2017

I hereby agree:

- To open my studio during the hours of 10am-5pm September 15, 16, 17, 2017, and agree to be present during those hours.
- To have recent original, one-of-a-kind artwork prominently displayed at Open Studio Tour.
- To abide by the restrictions on commercial reproductions: a maximum of 20% space /volume allocation, less prominent placement, clear and accurate labeling of work as a reproduction. (Any item sold at Open Studio Tour must be from Artist's own images.)
- To show visitors my actual workspace, materials, tools, and works-in-process and make my process visible in a way that will enable visitors to learn more about my art form.
- To discuss and, if possible, demonstrate my working process of making art. (Hosted artists and plein-air painters must comply with all the above except workspace.)
- To provide four professional looking digital images of my art, studio, and myself, including biographical information for the brochure, public relations/advertising, and website within the announced deadlines.
- To serve on one of the designated committees that helps to produce Open Studio Tour. (These committees may include mailing, publicity, screening, signage, brochure-map distribution, preview show(s), and grant writing.) _____(initial here)
- To attend the 3-4 general meetings that are held to disseminate information and organize a smooth running tour. _____(initial here)
- To pay fees for my equal portion of the operating expenses for Open Studio Tour. (2016 fee will be \$225 due at first OST meeting.) **Make check payable to Greater Gig Harbor Community Foundation (GGHCF).**

I understand that:

- If another artist hosts me, he/she must be a qualified OST participant.
- I cannot invite non-member artists to show work in my studio
- Alcoholic beverages will not be offered if refreshments are provided at my studio.
- If I fail to comply with the Open Studio Guidelines and conditions listed herein, I will be ineligible for subsequent Open Studio Events.
